ELIGIBILITY

- ✿ The show and sale is only open to Cheshire Art League members whose dues are paid up for the year beginning on September 1, 2009.
- ✿ Artwork must be completed solely by the submitting artist.
- ✿ Giclée prints and other types of reproductions ARE ACCEPTABLE.
- ✿ Photography is acceptable.
- ✿ No sculptures, no easels.
- ✿ Artists may hang a maximum of 3-5 framed pieces.
- ✿ Framed artwork must be suitably wired for safe and secure hanging.
- ✿ An additional 20 pieces of unframed/unmatted artwork can also be displayed in a personal print art rack, which must be supplied by the artist.
- ✿ It is recommended that you display any unframed/unmatted artwork in protective plastic sleeves.
- ✿ The Cheshire Art League officers and Art Show & Sale Committee reserve the right to exclude any piece(s) submitted for entry for whatever reason.

SALES:

- ✿ All work must be for sale.
- ✿ NO commissions will be taken on sales.
- ✿ Payment for purchased artwork will be by cash or check made out to the artist. In the absence of a C.A.L. artist or show committee member, the Cheshire Nursery has kindly offered to collect payment separately from their own cash register transactions.

SETUP:

- ✿ You must set up your own artwork on Wednesday, November 18th, from 2:00–5:00 PM.
- ✿ Artist will need to submit a list of artwork titles, mediums and prices at the time of setup.
- ✿ Identification, including artist's name, artwork title, medium and price needs to be attached to the back of each piece of artwork. Hung artwork should also have this information displayed on the front of or next to each piece.
- ✿ Please provide your own business cards / contact information and a way to display them.
- ✿ You may also wish to display a bio/artist's statement (8 ½" x 11" max) with your artwork.

PICKUP:

- ✿ All unsold artwork must be removed by the artist or their representative on Sunday, November 22 before 5:00 PM.

ENTRY FEE:

- ✿ The cost will be \$10.00 per artist to cover any reception and/or show-related expenses.
